## ANNUAL REPORT - FY 2015-2016 March 1, 2017

#### Mission:

Feeding the needy by: Working in partnership with local non-profit agencies to eradicate hunger in Marion County.

### Accomplishments: (Fiscal Year, July 1, 2015 – June 30, 2016)

- We distributed 2,744,450 pounds of food products through 41 approved pantries to those living in Marion County needing food. This was accomplished with one (1) full-time Executive Director, one (1) part-time Office Manager, two (2) part-time truck drivers, and one (1) part-time Development Director/Fundraising Coordinator. Food products were obtained from the following sources:
  - The Grocers' Alliance Program (Initiated this fiscal year.)
  - Farmers Feeding Florida Program (Initiated this fiscal year.)
  - Direct Food Donations
  - Via contract with Second Harvest Food Bank of Central Florida, Inc., a member of the Feeding America Network (A majority of the food products distributed are obtained from this source which includes our Mobile Pantry Program.)
- First Step Food Bank, Inc. began organizational improvements to become accredited by the Better Business Bureau Wise Giving Alliance.
- > The first Development Director/Fundraising Coordinator was hired as a part-time employee.
- Creation of a website was begun.
